To understand the impact of plastic pollution we study the 5 subtropical gyres by sailing through them. Together with our partners, Pangaea Explorations and Algalita Marine Research Foundation, we organize research expeditions, inviting scientists, journalists and other sailors to join the crew.

To communicate about the global impact of plastic pollution, we share our findings through multimedia outlets and peer-reviewed publications. These include print and television media, websites and blogs, lectures and school outreach, and a traveling exhibition about plastic pollution to museums, science centers and aquariums.

To eliminate plastic pollution we employ strategies that work. To stop the flow of plastic to the sea we advocate new materials, better designed products, fair legislation, and engage in consumer education. Post-consumer cleanup efforts focus on coastal and island debris removal and mitigation.
